Wounded Warrior Project to take part in BGC Partners 7th Annual Charity Day

Wall Street Fundraiser Commemorating 9/11 and Benefiting the Wounded

Jacksonville, FL (September 9, 2011) – As part of BGC's seventh annual Charity Day taking place on Monday, September 12, 2011, Wounded Warrior Project (WWP), along with numerous other charities, will receive donations from BGC Partners and recognition from a host of celebrities.
